

- 1) The brand or make of consumables should be specifically stated and wherever the necessary, complete set of specifications and quantity should be given.
- 2) If asked, Demo/Sample should accompany the quotations.
- 3) Sales tax, General Tax, Central Sales tax, Customs duty, Insurance charges, Packing and Forwarding charges, if, not included in the prices quoted, should be clearly specified.
- 4) The period of validity of the quotation should be at least 90 Days. Offers subject to prior sale may please be avoided.
- 5) The delivery period is to be clearly mentioned in the quotation, and it should not be more than 30 days.
- 6) The mode of delivery of the stores may be mentioned. The delivery should be F.O.R. Surat or at the Institute.
- 7) All concessions available to an educational institution should be specified and also taken into account while quoting.
- 8) Payment will be made only after satisfactory demonstration of the supplied items.
- 9) Quotation should accompany the complete details with brochure/catalogue. List of Institutes/firms where similar consumables are supplied should also be attached.
