**ONLINE PAYMENT OF MESS ADVANCE (EVEN SEMESTER -2019-20)**  
**(Except IIIT, Surat Hostel Students)**

It is mandatory for all enrolled hostel students to pay mess advance using **Online MIS portal** of the institute.

The following instructions are to be noted -

  - (i) Enter Your Admission No. as user name and password which is set by you.
  - (ii) Follow as per the guidelines to complete the procedure:
  - (iii) All the IIIT, Surat hostel students are required to pay their mess advance of Rs.16,500.00 into their respective hostel account.
    - Demand draft of Rs. 16500/- for boys and girls in favour of respective hostel. {e.g. Chief Warden, Gajjar Bhavan (IIIT-I) for boys, Chief Warden, Mother Teresa Bhavan (IIIT-I, II & III) for girls & Chief Warden Tagore Bhavan (IIIT-II & III) for boys }. The demand draft must be payable to Surat only.
  - (iv) Online Payment of mess advance as mentioned below will be operated from **09-12-2019**. Last date of payment Without fine is **10-01-2020**.
