The general conditions for the enquiry are as under:

- 1) The Agency is requested to contact estate electrical office for any clarification before submitting quotation for the inquiry.
- 2) The Agency has to submit for all government challans of lift license renew, Name change of lift license holder and duplicate lift license.
- 3) Sales tax, General tax, Central Sales tax or GST, if not included in the prices quoted, should be clearly specified.
- 4) The period of validity of the quotation should be at least 60 Days.
- 5) The agency will be paid after SVNIT has received all license as required.
- 6) The agency will have all responsibilities whatsoever till the SVNIT receives lift license as required.
- 7) This Institute is registered with the dept. of scientific & industrial Research (DSIR) for the purpose of availing custom duty exemption & central excise duty exemption, and hence the certificate to this effect will be issued wherever it is necessary on demand.
- 8) Payment is normally made by cheque drawn on the S.V.N.I.T. Branch Office of State Bank of India, Surat-395007 within a period of thirty days from the date of receipt.
- 9) The Director reserves the right to accept stores, which are not strictly in confirming with the specifications but otherwise, found suitable.
- 10) Majority of the lifts are of Jhonson make.
