- 1. The candidates have to show their ID proof to security person at main gate to enter the campus.

Arrival and Accommodation at the Campus

- All the students are instructed to report at the Security Gate. Security will guide you for the <u>GAJJAR BHAVAN</u> (Male) / <u>MOTHER TERESA BHAVAN</u> (Girls) Hostel. Subsequently, in the next morning, they have to go for RAPID-Antigen test. The RAPID-Antigen test will be undertaken within the institute at designated place in the campus before proceeding for document verification.
- The candidates can avail accommodation facility in the <u>GAJJAR BHAVAN</u> (Male) /<u>MOTHER</u> <u>TERESA BHAVAN</u> (Girls) hostel inside the campus. They have to bring their own Bed sheet, Pillow, Blanket and Lock & Key for door. The decent used mattress will be given in the rooms.
- Ph.D. candidates have to consult their respective supervisor whether they wish to reside at the
 Institute for spring semester of the A.Y. 2020-21 or go back immediately after their document
 verification. In case they wish to go back after the document verification, they are permitted to go
 back
- The arrangement of all the candidates are made for Packed meals, breakfast, tea/coffee in their respective rooms at <u>GAJJAR BHAVAN</u> (Male) / <u>MOTHER TERESA BHAVAN</u> (Girls) on chargeable basis for maximum two days to candidates of states other than Gujarat and for one day to the candidates of Gujarat state. If the student wishes to stay for spring semester of the A.Y. 2020-21, he/she will be under observation for 7 days in the respective hostel and after word he/she will be shifted to the allotted room/hostel.
- Once candidate enters the campus, he/she will be allowed to leave campus only for their return journey.
