- 1. The candidates are required to submit scanned copies of the documents mentioned in the remarks column against their name through email on office@ched.svnit.ac.in mail id on or before July 16, 2021.
- 2. Online document verification will be done from 9:00 AM onwards on July 19, 2021. After document verification, the eligible candidates are required to appear for the Online Written Test on Google Form/Google meet. The link will be sent to the candidate's email id mentioned in their applications.
- 3. The test will be of 1 hour duration (10:30 AM to 11:30 AM) consisting of multiple-choice questions of Core Chemical Engineering Courses.
- 4. The online written test will be followed by the Online Presentation (about 10-15 minutes) on the proposed research topic and Interview on July 20, 2021 from 11:00 AM onwards. The eligible candidates are required to present the topic in which he/she aspire to pursue his/her Ph. D. Program.
- 5. All Full time sponsored candidates (FSC), Part-time external candidates (PEC), and Full-time study leave candidates (FSL) must produce the following documents in **ORIGINAL** at the time of document verification

- Appointment letter issued by the current employer
- Experience certificate
- Salary certificates/slips of last 12 months
- Income-tax return or Form-16 of last financial year
- All other documents/certificates as mentioned on the institute Ph.D. application portal
- 6. External candidates must produce a relevant sponsorship certificate strictly as per the format given in **Appendix-III** on the Ph.D. application portal at the time of written test/interview/presentation. They have to produce relieving certificate from their organization at the time of registration, strictly as per **Appendix-IV** on the Ph.D. application portal.
- 7. In case the FSF, PEC and FSL candidates are not able to submit the requisite sponsorship certificates at the time of interview, a certificate in the prescribed format as per **Appendix-VII** on the Ph.D. application portal is to be submitted at the time of interview. Without such certificate, the candidates will not permitted for appearing test/interviews for the PhD admission.
