**Attention: Students resided in Swami Vivekanand Bhavan in Academic Year 2019-20**

With reference to the minutes of meeting of Task Force Committee, circulated on November 07, 2021, the next semester is likely to start in offline mode. Therefore, it is required to make necessary arrangement of accommodation for the students of B.Tech.-III, IV and M.Sc.-V in Swami Vivekanand Bhavan. Most of the hostel inmates of Swami Vivekanand Bhavan of Academic Year 2019-20 went to their homes during pandemic due to Covid-19, by locking their rooms. Those rooms are locked since then. It is now required to vacate these rooms by the respective students, for maintaining the rooms in order to allot them to the newly admitted students.

**Hence, these students who stayed in Swami Vivekanand Bhavan in A.Y. 2019-20 are hereby instructed to vacate their rooms by taking their luggage with them during December 05-19, 2021. Alternately, they can keep their luggage in common room in consultation with hostel supervisor.**

They are also advised to send one e-mail to the Chief Warden ([cw1\\_svb@svnit.ac.in](mailto:cw1_svb@svnit.ac.in)) at least two days prior to their arrival, mentioning the date and time when they are coming to hostel. Those who are unable to come personally can send their close relatives / friends with the key by informing to the Chief Warden through email.

All concerned students are requested to note the following:

- No accommodation will be provided to student/accompanying person inside/outside campus.
- Students will be allowed to enter the hostel rooms to take away their luggage and leave the campus in 4 hrs.
- The students will not be allowed for any undesirable movement on the campus/ hostels.
- They are also instructed to properly follow the handover procedure with hostel supervisor before vacating the hostel and sign on stock register in presence of hostel supervisor.
- You are instructed to follow the Lock/Unlock guidelines by your respective State Governments/ District Government/Municipal Corporation/Panchyat etc. If guidelines permit, then only you are allowed to visit the institute.
- The students are strictly required to follow the COVID-19 guidelines issued by Central/State/Local administration/SVNIT administration issued from time to time during the visit.
