Important Note:

- The candidates have to show ID proof to security person at the main gate to enter into the campus. The Institute bus will drop the candidate at venue of document verification.
- No candidates will be allowed for any undesirable movement on the campus ii. except the designated places mandatory for the document verification.

List of Documents:

The FIR candidates are required to bring the following **ORIGINAL** documents along with their self-attested photocopies.

- 1. Document for proof of date of birth
- 2. Photo ID proof as per Government of India norms.
- 3. Degree certificate of B.E./ B.Tech.
- 4. Grade/Mark sheets of qualifying examination of all semesters (M.E./ M.Tech).
- 5. Degree/ Provisional certificate (M.E./M.Tech).
- 6. GATE score card
- 7. Certificate of category (SC/ST/OBC-NCL/EWS) issued by the competent authority. In case of OBC-NCL/EWS category, the certificate must be issued on or after **April 01,2021.**
- 8. Two passport size recent photographs.

The FSC/ PEC / FSL candidates are required to bring the following **ORIGINAL** documents with their self-attested photocopies.

- (1) Sr. No 1 to Sr. No. 5 as mentioned above (in case of FIR candidates)
- (2) Appointment letter issued by the present employer
- (3) Experience certificate
- (4) Salary certificate / slips of last 12 months
- (5) Income tax return or Form-16 of last financial year
- (6) Sponsorship certificate (ignore, if original document is already submitted)
- (7) Any other documents as mentioned in the information brochure of PhD admission.

<u>Venue: Document Verification will be done at Swami Vivekanand Bhavan</u> (Hostel, H-13)

Accommodation:

- The Candidates can avail accommodation facility in the Swami Vivekanand Bhava (Boys) /Mother Teresa Bhavan (Girls) hostel inside the campus. They have to bring their own Bed Sheet, Pillow, Blanket and lock & Key for door. The decent used mattress will be given in the rooms.
- Once candidates enterthe campus, they will be allowed to leave campus only for their return journey.
- Arrangement will be made for packed meals, breakfast, tea/coffee in their respective rooms at Swami Vivekanand Bhavan (Boys)/Mother Teresa Bhavan (Girls) on chargeable basis.
 - Candidates, arriving the campus, have to go through RAPID-Antigen test. The RAPID-Antigen test would be done within the institute at

specified place in the campus. The candidates, who are visiting the campus, have to restrict their movement in close vicinity of their respective allotted accommodation. Subsequently, in the next morning, they have to undergo the ANTIGEN test before proceeding for document verification.

- Accommodation will be provided for maximum two days(the candidates coming from states other than Gujarat) and for one day (the candidates belonging to the Gujarat state).
- The candidate (Research Scholar) may be allowed to stay in campus after getting the permission from the competent authority. For this, they have to write an application to Chairman Task Force, SVNIT, Surat with recommendation of the supervisor and forwarded the same through the Head of the Department.
- Students, willing to stay in hostel, are required to take hostel admission.
 Students have to undergo seven days and fourteen days of self-observation who belong to the Gujarat State and other states respectively at Swami Vivekanand Bhavan (Boys)/ Mother Teresa Bhavan (Girls) before staying in the Hostels.
