ANNEXURE - I

Important Instructions to Report at the Campus and Staying in the Hostel

1. The students have to show their ID proof and print out of filled in Declaration/Undertaking form through **MIS** duly signed by Student and their Parents/Guardian to security person at the institute main gate before entering the campus.
2. Students reporting to the campus, have to compulsorily bring the RTPCR test report of COVID, irrespective whether they have taken both the doses of vaccine. **No students will be permitted to enter without the valid RT-PCR report.**
3. No students will be allowed for any undesirable movement on the campus.
4. Students must follow all the steps to protect themselves and others at all times, including proper use of face masks, social distancing, and hand hygiene.
5. Students are strictly required to follow the COVID-19 guidelines as issued/amended from time to time by Central/State/Local administration/Institute during the visit and at campus.
6. Any student with COVID-19 symptoms upon the arrival at the campus must report to the Institute Doctor/Hostel Supervisor immediately without fail. Such students are advised to isolate themselves till the RAPID-Antigen test is conducted.
7. **Students returning to hostels have to follow the procedure as mentioned in the Flow Chart in Annexure-II.**

Instructions for Self-isolation period

- Proceed to Gajjar Bhavan (Boys), Mother Teresa Bhavan (Girls), Raman Bhavan (Family) for self-isolation period. The RAT will be conducted in every morning at the designated places in the campus. In case of negative RAT, students will have to complete the 7days isolation (Gajjar Bhavan-Boys; Mother Teresa Bhavan –Girls; Raman Bhavan -Family), If found positive, students will have to shift to the covid isolation facility at the campus. **It is instructed to every student to stay in their rooms during the self-isolation.**
- They have to bring their own Bed sheet, Pillow, Blanket and Lock & Key for door. The decent used mattress will be given in the rooms.
- During self-isolation period, the arrangement will be made for Packed meals, breakfast, tea/coffee in their respective rooms, on **payment basis** (food, transportation, and packaging charge).
- During self-isolation period, the students are not supposed to move in the hostel unnecessarily. They must maintain the social distance and not interact with any other students.
- Students will self-monitor their health by themselves during self-isolation period. In case of any symptoms will appear, they must immediately report the same to the respective hostel supervisor and seek medical consultation with the institute CMO.
- Once student enters the campus, he/she will not be allowed to go out of the campus until the institute permits.
