The quotations should be furnished with the following information.

- 1. The brand or make/model of each item should be specifically stated and wherever necessary, complete set of specifications and dimensions should be given.
- 2. If asked, samples are accompanying the quotations.
- 3. GST or any other tax, Insurance charges, Packing & Forwarding charges, and any additional charges, if not included in the prices quoted, should be clearly specified.
- 4. The period of validity of the quotation should be at least 45 Days. Offers subject to prior sale may please be avoided.
- 5. The delivery period is to be clearly mentioned in the quotation.
- 6. The mode of delivery of the items may be mentioned. The delivery should be F.O.R. Surat or at the Institute.
