Your quotation should reach the undersigned on or before 06/10/2025 at 05:30 P.M., addressed to **The Dean (Planning & Development), Estate & Store Section, New Admin Buildings. V. National Institute of Technology, Ichchhanath, Surat – 395 007, Gujarat.**

The quotations should be furnished with the following information.

- 1 Attested copy of the valid Registration Certificate of GST & PAN.
- The contractor must carry out a site visit before submitting the quotation, in order to assess the actual site conditions and requirements. A **site visit certificate**, duly signed by the concerned authority, must be uploaded/attached with the quotation as per the format provided in the Annexure.
- 3 The contractor must quote the rate **against each item individually** in the Schedule of Quantities. Failure to quote for any item may lead to rejection of the quotation.
- 4 The rates specified in the quotation are for Repair work of non-working ductable AC system installed at VNSGU Convention Hall, Surat on a F.O.R. Institute basis.
- 5 GST and any additional charges such as transportation or any other convenience charges should be taken into consideration while quoting the offer.
- The offered price F.O.R. SVNIT should be clearly specified at the concessional rates allowed to educational institutions as per the relevant notification of the Government.
- 7 The supply order is for a period of 7 days from the date of issue of a confirmed order.
- The period of validity of the quotation should be at least 30 Days. Offer subject to a prior sale may please be avoided.
- 9 Payment shall be made within a period of 30 days from the date of satisfactory completion of the work & submission of bills and official procedure from the account section of the institute.
- 10 All concessions available to an educational institution should also take into account while quoting.
- An offered quotation may be rejected if any ambiguity is found.
- 12 The contractor has to take all safety precautions. In case of any accident during execution of work/supply leading to injuries/damages to human being/equipment, or loss of life the bidder shall be fully responsible for settling all claims and indemnify the department against any claim arising out of such accident.
- 13 The acceptance of inquiry will rest with the competent authority (The Director) who does not bind himself to accept the lowest one and reserves the right to accept or reject any or all the inquiry tenders without giving any reasons thereof.
- 14 The Director reserves the right to accept an offer, which is not strictly conform to the specifications but is otherwise, found suitable. If offers do not comply with standard specifications or are found in broken condition, the same is to be taken from the institute, at the cost and responsibility of the supplier.
- 15 All works will be supervised by the **Decoration & Stage Management Committee** for the 21st Convocation constituted by competent authority SVNIT.
- The contractor shall be responsible for providing all materials and execute the repairing work of ductable A.C system as per standard specifications, suitable to the site requirements, and as directed by the Committee.
- 17 The date specified for the Convocation is **tentative**. The competent authority reserves the right to revise the Convocation date. However, the contractor must remain prepared to execute the specified work as per the revised schedule and directions of the Committee.
- 18 The contractor shall also be required to execute part or all of the work **within the SVNIT campus**, if so, directed by the Committee, in addition to the VNSGU Convention Hall.
- All materials and installations must meet standard specifications and the repairing work should be fully completed one day prior to the convocation and that should be satisfactory to Decoration & Stage Management Committee. The contractor must quote rates accordingly.

- 20 The quantities mentioned in the **Schedule of Quantities** are **estimated and indicative only**, provided solely for reference purposes. These quantities are subject to **variation—either increase or decrease**, **may or may not execute** —based on the **actual site requirements** and as per the norms and instructions of the institute.
- 21 The contractor shall **not be entitled to claim any compensation or revision of rates** on account of such variations in quantity.
- The **rates/prices quoted** by the contractor in the quotation shall be treated as **firm and final** and shall **remain fixed for the entire contract period**, irrespective of any changes in quantity, duration, or other conditions, except where explicitly approved in writing by the competent authority.
- 23 All wiring works if any required and earthing must be executed in accordance with **electrical safety standards**.
- 24 If requested, the contractor must produce supporting documents for executed works/items at any stage. Failure to provide documents may result in exclusion of such items from the final bill.
- 25 No escalation in price shall be considered for any reason whatsoever during the contract period, including but not limited to fluctuations in market rates, fuel prices, transportation, or labor charges.
- The contractor shall protect all materials delivered on site from weather damage, mishandling, or injury. The contractor will remain liable for all damages or losses caused due to negligence or omission of his staff, workers, or subcontractors, and all rectifications shall be at his own cost to the satisfaction of the **Decoration & Stage Management Committee**.
- 27 The contractor is responsible for **deploying qualified personnel** to operate generators, lighting, sound systems, and other equipment throughout the event.
