1. The candidates have to report in offline mode for document verification at the Seminar Hall (First Floor), Wing-A, Department of Civil Engineering at 9:30 AM on June 24, 2024 (Candidates are advised to check

regularly the Institute website for updates, possible modifications etc.)

- 2. At the time of Document Verification, candidates are required to bring one set of self-attested photocopies of all the necessary documents along with ORIGINAL documents as mentioned in the information brochure of PhD admission.
- 3. Compliance of remarks against each candidate is mandatory. Without the necessary compliance candidates will not be entertained/interviewed.
- 4. The candidates will have to give PPT presentation (of about 10 minutes) on the topic in which he/she aspires to pursue his/her research work, which will be followed by an interview.
- 5. The candidates will not be entertained for admission without production of the all-necessary documents as mentioned in the information brochure of Ph.D. Admission on the day of reporting in the Department of Civil Engineering.
- 6. Confirmation of admission (if selected) is subject to submission of all relevant documents applicable at the time of registration as specified in the information brochure.
- 7. This list is not in the order of merit.

### **List of Documents:**

The FIR candidates are required to bring the following ORIGINAL documents along with their self-attested photocopies

- 1. Document for proof of date of birth
- 2. Photo ID proof as per Government of India norms.
- 3. Grade/Mark sheets of qualifying examination of all semesters (B.E./ B. Tech)
- 4. Degree certificate of B.E./ B. Tech
- 5. Grade/Mark sheets of qualifying examination of all semesters (M.E./ M.Tech.)
- 6. Degree/ Provisional certificate (M.E./M.Tech).
- 7. Certificate of category (SC/ST/OBC-NCL/EWS) issued by the competent authority. In case of OBC-NCL/EWS category, the certificate must be issued on or after 1st April 2024. (All Certificates as per Central Government Format)
- 8. Valid GATE score card
- 9. Two passport size recent photographs.
- 10. Master degree candidate, who has submitted the Dissertation/Thesis or appeared in final semester/final year examination are provisionally eligible. In case of the candidates whose qualifying degree results are not declared, they have to submit their final results by 15th September/15th February for admissions in Autumn/Spring semesters respectively. Further More, the candidate has to submit the proof of submission of the M. Tech Dissertation at the time of interview. Such candidates are required to give an undertaking as prescribed in Appendix - VI.
- 11. Any other documents as mentioned in the information brochure of PhD admission.

ERS candidates for Ph.D. must enclose self-attested copies of the following documents/certificates, if serving. Same must be produced in ORIGINAL at the time of interview / physical documents verification.

- 1. Sr. No 1 to Sr. No. 7 as mentioned above (in case of FIR candidates)
- 2. Appointment letter issued by the current employer.
- 3. Experience certificate duly signed by competent authority on the letter head of the Company/Organization/Institute. राष्ट्रीय प्रौद्योह
- 4. Salary certificates/slips of last 12 months.
- 5. Income-Tax return or Form-16 of last financial year.
- 6. All other documents like degree certificates, sponsorship or no objection certificate.
- 7. Any other documents as mentioned in the information brochure of PhD admission.

#### Note:

- 1. Sponsorship Certificate should be from the same organization who has issued the Appointment letter, Experience certificate and Salary slip.
- 2. Salary Slip, Experience Certificate of one year must be from same (single) organization.
- 3. Confirmation of admission (if selected) is subject to submission of sponsorship letter (if applicable) at the time of registration as specified in the information brochure.
