- 1. The applications received for the post of Assistant Professor Grade-II (Level-10) in the Department of Artificial Intelligence and the Department of Computer Science & Engineering till the last date have been scrutinized.
- 2. The displayed lists of eligible, conditionally eligible, and not eligible candidates are provisional.
- 3. The eligibility of the candidate is assessed as per Schedule 'E' of the NIT Statute as amended from time to time.

 $\geq$ In teaching demo, each candidate is required to teach UG-level course of his/her choice in the respective discipline for about 10 minutes using a blackboard/whiteboard only.

### 5. Eligible & Conditionally eligible Candidates:

- The candidate belonging to the SC/ST/OBC(NCL)/EWS category has to produce an original certificate as mentioned in the advertisement notification at the time of the written test/interview, failing in doing so, his/her candidature will be considered in the UR category only, and he/she has to pay the application processing fee as per the UR category.
- b. The person employed on regular employment in Government, Semi-Government organizations, the Public Sector, Autonomous bodies of the Govt. of India, or the State Government must bring an original copy of No Objection Certificate (NOC) at the time of the written test/interview, if it is not submitted with the application form or not applied through the proper channel; failing in doing so, his or her candidature may be cancelled.
- c. All the necessary documents/certificates in original have to be produced for verification at the time of written exam/interview, failing in doing so, his/her candidature for further process of recruitment stands cancelled.

- 6. The Institute shall not be responsible for any error/omission/commission/suppression of any information provided by the applicants, knowingly or unknowingly, while filling up the application form. In case the applicant gets shortlisted/selected on the basis of incorrect, forged, or fabricated details, his/her candidature shall be liable to be cancelled at any stage of recruitment or during the tenure of service, and appropriate legal action under applicable law shall be initiated against such applicants. The Institute reserves the right to alteration/modification/correction in the list of eligible, provisionally eligible, and 'not eligible' candidates.
- Mere appearance for Teaching Demo/ Personal Interview doesn't entitle a candidate to be considered for selection. APPLICANTS MUST FULLY SATISFY THEIR ELIGIBILITY AS PRESCRIBED ON THE LAST DATE OF APPLICATION BEFORE APPEARING IN TEST/ INTERVIEW.
- 8. If the candidate is inadvertently allowed to appear in the Teaching Demo/Personal Interview, who otherwise doesn't fulfil minimum eligibility requirements, the candidate can't use it as a right to claim at later stage that candidate meets the eligibility requirements. The Institute reserves the right not to allow a candidate for selection if it is found that, Minimum eligibility requirements are not fulfilled/ Inadequate proof/false documentation / Non-submission of valid NOC/ Any other reasons etc.
