The candidate having objection about their ineligibly may submit in writing with all supporting documents to Deputy Registrar (Establishment), SVNIT, Surat 395007 through e-mail at <u>dy estt@svnit.ac.in</u> so as to reach on or before August 21 2024. The Institute will not consider any request for extension of time for submission of documents beyond the stipulated time.
- **5.** After submission of documents and scrutiny, if the candidates are made eligible, following certificates will be required to be produced on appearing for written test/ interview at SVNIT, Surat
 - Proof of Identity issued by the Govt. (in Original) such Aadhar Card / Passport / Driving License / PAN Card / Voter Card etc.
 - The original certificates for their educational qualification and relevant experience mentioned in their application form.
 - Failing to produce above documents, the candidates will not be permitted to appear for Written test/ Interview. No photocopies of the above documents shall be entertained.
- **6.** If at any stage of recruitment, the category certificate of any candidate is found to be faulty or non- genuine the candidature of such candidate shall be cancelled and he/she shall be barred for future recruitment in the Institute
