10.	<u>Selection Process:</u> The interested candidates may appear for Walk-In-Interview on 06 January 2025. The final selection will be based on the performance of candidate during personal interview at SVNIT Surat.	
11.	<u>General Instructions & Other Information:</u> i. The engagement would be purely on contract basis. Any claim for absorption at the regular position in the institute will not be entertained at any point of time. ii. The engagement will be subject to their medical fitness and police verification. iii. The Institute reserve the right to terminate the services of the appointee at any by giving one-	

- month notice or payment of one-month salary in lieu thereof by either side without assigning any reason.
- iv. The appointee will not be entitled for any medical facility/ accommodation or any other type of allowances.
 - v. The appointees have to attend the office six days a week.
