Educational and other qualifications & experience required for recruitment Bachelor's Degree from a recognized University/ Institute with Minimum 15 years' experience in in the Army/Central Paramilitary Forces in Govt. Organization/Government Educational Institutions. Preference will be given to the person who have served in the Army / Central paramilitary Forces or such uniformed services. Desirable Educational Qualification and Experience		
	Candidates must have experience in crowd control, dealing with students in residential campus, Police Station Protocols and familiarization with documentation procedures during VIP/VVIP visits, mobile patrol and relevant.

	<ul> <li>Supervising all the aspects of security and safety measures for safety of the properties of the Institute</li> <li>Responsible for proper maintenance of all records relating to movement of men and material, proper deployment of security personnel in all shifts, handling of visitors, working of security cameras, enforcement of security rules, regulations and procedures, etc.</li> <li>The candidate should be able to work round the clock (24x7) as and when required and attend in person to any security related emergency.</li> <li>To conduct investigation into the serious cases such as theft, pilferage, accident, sabotage or subversive activities etc. Hence the candidate should be conversant with Security Rules/ Regulations and procedures to deal with local authority of law &amp; order as and when required. Knowledge of local language will be an added advantage.</li> <li>Prepare duty rosters of security personnel.</li> <li>To supervise patrolling around the campus and to prevent and detect signs of intrusion and ensure security of doors, windows, and gates.</li> <li>Regulate movement of vehicular traffic/parking control within the campus and in front of the gates.</li> <li>Handling of Institute's Transportation requirements.</li> <li>Any other duty as may be assigned by the higher authority from time to time.</li> <li>The candidate will be required to stay in the campus on selection.</li> </ul>

	days' notice or payment of 15 days' salary in lieu thereof by either side without assigning
