- First Class in M.E./M. Tech. in relevant specialization with B.E./B.Tech in Mechanical/Production/ Metallurgy/Industrial.
- Preference will be given to GATE qualified candidate with experience in additive manufacturing/3D printing/manufacturing processes or other relevant fields of above mentioned project.
- Relaxations will be given to SC/ST/OBC candidates as per Govt. of India guidelines.

- I. The interested candidates will be required to submit their application online through Google form at above link with all essential details and scanned copy of required documents before the last date. Candidates need to bring a set of self attested copies of marksheets and all the relevant documents along with a passport size photo on the day of interview. Candidates also need to bring corresponding original documents on the day of interview for verification purpose.
- II. Candidates need to positively mention their correct e-mail ID and Mobile number in the application forms, failing which their candidatures may be rejected.
- III. The application received within the stipulated time will be screened by a committee and a list of eligible candidates shortlisted for interview/test will be displayed on the institute website along with the schedule of the interview/test. The screening committees will devise its own criteria for shortlisting of candidates for interview/test. Merely fulfilling main eligibility criteria may not be sufficient to be invited for the interview/test.
