4.	Method of Recruitment	Purely on contract basis for one year which may be extended further for one year based on performance of the candidate.
5.	Monthly Pay / Remuneration	Consolidated Rs. 80,000/- per month
6.	Age Limit	Preferably not more than 50 years on the last date of submission of application
7.	<b>Job Profile: -</b>	<ul style="list-style-type: none"><li>• He/She have to attend duty at Institute Health Center to provide medical treatment to the residents/ students of the Institute.</li><li>• He / she should be able to provide emergency services as and when required.</li><li>• In case of medical emergency he / she should be available on call basis/ stay in the campus as per institute requirement.</li><li>• Job Profile mentioned above is illustrative. Roles/Jobs in addition to the above mentioned may be assigned by the Institute from time to time for the above post.</li><li>• Preference will be given to the female candidate.</li></ul>
8.	<b><u>Educational qualification and Experience:</u></b>	<p>Essential: <b><u>Educational qualification:</u></b> MBBS Degree or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register.</p> <p><b><u>Desirable:</u></b> Post Graduate Qualification, preferably MD in General Medicine, or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register.</p> <p>Note: i) The Medical qualifications possessed by the candidates should have the recognition of the Medical Council of India. ii) Completion of compulsory Rotating Internship Certificate, [Registration Certificate, an official document showing name of College / Institution from where degree / diploma has been done and official document showing name of the institution from where experience has been gained are required.]</p>
9.	<b><u>Application Process:</u></b>	<p>The eligible interested candidates have to download the application form and submit the hard copy of their filled in applications through Speed/ Registered Post in prescribed format with copies of certificates &amp; Mark-sheets, to <b>The Deputy Registrar (Establishment), Sardar Vallabhbhai National Institute of Technology, Surat, Ichchhanath, Dumas Road, Keval Chowk, Surat, Gujarat-395007</b> so as to reach on or before <b>22<sup>nd</sup> November 2024</b>. <b>The envelop should superscribed as Application for the Post of Medical Officer on Purely Contract Basis (Last Date 22<sup>nd</sup> November 2024).</b></p>

10	<p><b><u>Selection Process:</u></b></p> <p>The shortlisted candidates will be called for interview. The final selection will be based on the performance of candidate during personal interview at SVNIT Surat.</p> <p>Mere fulfilling minimum qualification and experience will not vest any right in candidate for being called for interview. The shortlisting parameters will be decided by the Institute and thereafter, adequate number of candidates, as decided by the Institute, will be shortlisted for interview. The decision of the Institute Authorities shall be final. No correspondence will be entertained in this regard.</p>
11	<p><b><u>General Instructions &amp; Other Information :</u></b></p> <ol style="list-style-type: none"> <li>i. The engagement would be purely on contractual basis. <b>Any</b> claim for absorption at the regular position in the institute will not be entertained at any point of time.</li> <li>ii. The engagement will be subject to their medical fitness and police verification.</li> <li>iii. The Institute reserve the right to terminate the services of the appointee at any time by giving one month notice or payment of one month salary in lieu thereof by either side without assigning any reason.</li> <li>iv. The incumbents shall be eligible for 8 days of casual leave in a calendar year. Any other leave shall not be admissible.</li> <li>v. The appointee will not be entitled for any medical facility/ accommodation or any other type of allowances.</li> <li>vi. The appointees have to attend the office six days a week.</li> <li>vii.
