At the outset Hon'ble Chairman welcomed all the members of the Board and thanked for sparing their valuable time to attend the BOG meeting.

Before transacting the business of the board, a presentation of proposed extension of Mechanical Engineering Department and Computer Engineering Department was made by respective Heads of the departments accompanied by technical advisor (Civil Works) of the institute, Dean (Planning & Development), Associate Dean (Planning& Development) and Additional Assistant Engineer (Civil) of SVNIT-Surat. The Heads of both the departments presented in detail requirement of space for various laboratories, class rooms, faculty cabins etc., before the august house. After detailed discussion amongst the members, the board unanimously decided to approve the requirement in principle. However, the Board directed the institute to review the plans with a comprehensive view of all expansion activities, for better optimization and austerity in infrastructure creation. Further, the Dean (Planning & Development) also appraised about the ongoing construction activities and business transacted during last three meetings of Building and Works Committee.
