The following items were discussed and resolutions were drawn accordingly:

Item 76.1: To confirm the minutes of the 75th Purchase Committee meeting held on 20th July, 2020.

Reso.76.1: “Resolved to confirm the minutes of the 75th Purchase Committee meeting held on 20th July, 2020.”

Item 76.2: To note and approve the action taken on the resolutions adopted by the Purchase Committee at its 75th meeting held on 20/07/2020.

Reso.76.2: “Resolved that the action taken on the resolutions adopted by the Purchase Committee at 75th meeting held on 20/07/2020 be noted and approved. However, the action on Resolution no. 3 be modified as ‘Referred back to Department’.”

Item 76.3: To consider and approve the proposal of Professor In-charge Central Computer Centre through Dean (P&D) to award work order for providing 128 Mbps (1:1) Internet Services each from Five bidder and one 128Mbps (1:1) Internet Services for Guest House and SVP School of the institute at lowest quoted (total 6 lines each of 128 Mbps) to M/s. GTPL Broadband Pvt. Ltd., Ahmedabad (2 Lines), M/s. BSNL Surat (2 Lines) and M/s. You Broadband India Ltd., Surat (2 Lines) at the total cost of Rs. 31,51,515/- (Rs. Thirty one Lacs Fifty one Thousand Five Hundred Fifteen Only) including all taxes and duties for one year i.e. from 01/09/2020 to 31/08/2021 with Security Deposit at a rate of 2.5% of the work order value with other terms and condition of the tender documents, the expenditure to be debited from internet facilities to Institute Grant - 1/335.

Reso. 76.3: The Committee noted that M/s GTPL Broadband Pvt. Ltd., Ahmedabad has quoted lowest rate at Rs.5,25,252.52/- (Rupees Five Lacs Twenty Five Thousand Two Hundred Fifty Two and Fifty Two Paise) including 18% GST for one line of 128 Mbps (1:1). The total requirement for the campus is 128 Mbps X 6 = 768 Mbps, which are met out from three different vendors. As practiced earlier, the rates of other two firms M/s. BSNL, Surat and M/s. You Broadband India Ltd., Surat were negotiated to be reduced to lowest one and were asked to provide Internet bandwidth services at the lowest vendor which were agreed by both. Accordingly, the committee adopted the following resolution(s);

“Resolved to recommend that all three parties (1/3) M/s GTPL Broadband Pvt. Ltd., Ahmedabad, (2/3) M/s BSNL Surat and (3/3) M/s You Broadband India Ltd., be given order to provide 2 x 128 mbps (1:1) Internet bandwidth at Rs.10,50,505/- (i.e.Rs.5,25,252.52/- X 2 = Rs.10,50,505/-) (Rupees Ten Lacs Fifty Thousand Five Hundred Five) inclusive of all taxes for one year, i.e., from 01/09/2020 to 31/08/2021 with security deposit from each vendors at the rate of 2.5% of the order value of Rs.10,50,505/- and with other terms and conditions mentioned in the tender document. The total order value for 3 providers will be Rs.31,51,515/- for the period 01/09/2020 to 31/08/2021. The expenditure will be debited from Internet facilities to Institute Grant 1/335. The payment will be released on quarterly basis.”

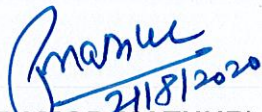
